I write further to my email of last week.

Our officers are continuing to work through a range of potential issues concerned with the disclosure of our salary support scheme recipient information. It is our intention to conclude how these matters can be addressed within the next week or two, subject to the availability of legal counsel and some practical operational matters.

In any event, I am hopeful that these conclusions will enable me to provide a some more definitive information to you in relation to when we will likely publish our salary support scheme recipient information and what, if any, restrictions on disclosure there may be. This should then allow me to identify whether the exemption previously explained to you (information for future publication) will likely apply to all or to some of the information that we hold. If any restrictions are likely to apply, I will then look to explain these to you fully within the context of the FOI legislation.

I trust that this makes sense, however, if you do wish to discuss this please feel free to call me on 685605. I am out of the office until Tuesday, but will be back n the office thereafter.
